

EDITOR'S DESK



Today's young people often get a bad rap! While research evidence shows that a substantial number of adults believe that the "average" teenager is wild, disrespectful, irresponsible and have an entitlement attitude, did you know teenagers played a key role in the Teen Dating Violence Awareness & Prevention initiative?

In 2004, the American Bar Association (ABA) began efforts to raise awareness about teen dating violence. The call to end it was formally recognized in 2006 and 2007 when both Houses of Congress declared the first week in February National Teen Dating Violence Awareness and Prevention Week. As part of the ABA's work, several adults and a teen from each state gathered together in Washington D.C. to inform the work. That movement was led by teenagers.


Three years later (2010) Congress declared the entire month of February as National Teen Dating Violence Awareness and Prevention Month (TDVAM). Teen dating violence or dating violence (TDV) is a pattern of controlling behavior by one teenager over another in a dating relationship and includes the following types of behavior: physical violence, sexual violence, psychological or emotional abuse and stalking.

According to the Centers for Disease Control and Prevention:

- About 1 in 12 experienced physical dating violence.
- About 1 in 10 experienced sexual dating violence.
- Some teens are at greater risk than others. Female students experienced higher rates of physical and sexual dating violence than male students.

Last year, the Ocala Police Department had 133 reported cases of teen dating violence, an increase of 33 cases the prior year (2023).

During the month of February, you can join the *Family Violence Prevention Workgroup* in its efforts to raise awareness about dating violence; talk to teens about healthy relationships and dating abuse and wear orange, the color that represents TDVAM, throughout the month of February. Join us an Tuesday, February 11, for Wear Orange Day to recognize of

COMMUNITY SPOTLIGHT THE FAMILY VIOLENCE PREVENTION WORKGROUP

Our mission is to organize activities that increase public awareness through education, training and collaboration with individuals, community leaders and public and private organizations.

In 2004 when Debra Vasquez, a beloved college professor, was shot and killed in front of the Ocala Police Department (OPD) by her husband, it shocked the community that something like that could happen so close to the front doors of the police station and no officers came out to assist her.



Although she never made it to the station's doors, the public outcry from the community was immediate after they found out that the doors were locked and no one was manning the front desk at the time of the shooting. Vasquez's death was one of seven domestic violence homicides that year and the 27th recorded since 1997.

The community's outrage was so overwhelming that then former police chief Sam Williams made some immediate departmental changes, which resulted in officers being assigned to mann OPD's headquarters and its two main substations around the clock.

A year later, (2005), the Marion County Children's Alliance Board of Directors hired a family violence prevention coordinator to undertake the challenges of addressing the impact of domestic violence in our community and to chair a taskforce officially named the Family Violence Prevention Workgroup (FVP). For the past 19 years, I have served as the chair, and our goal is to reduce family violence in Marion County by coordinating community resources and services to assist families in crisis.

Domestic Violence Awareness Month (DVAM), initially observed in October 1987, started as the Day of Unity in 1981 to connect organizations working to end domestic violence. In 1989, Congress passed a law making October National Domestic Violence Awareness Month.

Domestic violence, a serious and challenging public health problem, includes a range of abuse, including economic, physical, sexual, emotional and psychological, toward children, adults and elders.

The FVP Workgroup focuses on improving communication among agencies, organizations and individuals involved in family violence prevention; Educating all segments of the population on relevant facts of family violence; Improving the delivery of services to victims and survivors; Closing gaps in services and establishing benchmarks for participating agencies; and Working towards a unified strategy for all agencies.

Approximately 1 in 3 women and 1 in 10 men 18 years of age or older experience domestic violence. Annually, domestic violence is responsible for more than 1,500 deaths in the United States

Last year (2024) the Ocala Police Department received **620** reported cases of domestic violence, **133** teen dating violence cases and had **one** domestic violence homicide. The Marion County Sheriff's Office received **2,458** reported cases of domestic violence and had **five** homicides. The Workgroup provided assistance to **182** families (**270** children) from January through December and housed **8** families (21 individuals) in its domestic violence apartment.

The workgroup meets the second Monday of each month at 11 a.m. via Zoom and includes representatives from a variety of social service, non-profit and for-profit agencies, businesses and community members. We sponsor several annual events i.e. Night of Hope, Domestic Violence Walk, Community Walks, Lunch-n-Learns, etc. and facilitate free community trainings and workshops to raise awareness about the issue in addition to providing emergency resources and services to victims and survivors of domestic violence.

THE COMEBACK GENERATION

As a business and CRE strategist, I have an opportunity to work with businesses in many disciplines and of various sizes. Over the past couple of years, no matter where I've traveled, I have come in contact with young entrepreneurs in the 28 to 45 age range that are building some amazing businesses. From multi-chain restaurants, daycares and multi-family units to tech companies, food trucks and hair salons.

What has become very obvious is this group is the key to our nations economic comeback. The primary thought being they are well educated (street or school) and fearless. They understand risk taking and are willing to fail and learn to get to the next level. To put it plainly, "they get it! "I'll refer to this group as the "Young Turks" for the remainder of our conversation.

The Young Turks I have met span the full range of ethnicities and race and are 55% women. They have really studied the market space they want to invade and understand the importance of social engagement. They have worked for companies in the same space, figured out what their employers are doing wrong and are willing to take the risk themselves.

However, I have also noticed many Young Turks are operating their businesses on talent and intelligence, which invariably runs into problems when life interrupts. They don't always have a foundation built around core values, standard operating procedures or strategic planning.

Fortunately, this can be taught, and the Young Turks are willing to learn. I mentor more than 20 Young Turks from nascent entrepreneurs to those looking to open their second location. Some are already millionaires and others are under-employed and looking for a way out.

So why do I think they are the key to our comeback?

When you think about the current state of our economy, it's not only the lack of affordable housing, inflation or crime that is causing the problems, but sustainable growth. COVID changed consumer behavior and as a result, consumers are driven more by the emotive parts of life. This has been translated into more remote workers and an unwillingness on the part of employees to work in toxic environments.

The result of this change is slowed consumption for companies who have not adjusted to changes in their employees and customer's values and expectations. This has opened doors for the Young Turks who understand consumer behaviors, and many have been able to use their skills with social engagement to keep a steady flow of business.

It is this business smarts and determination that will prove to be the saving grace across many segments of our economy, but we (Baby Boomers & Gen X) need to do our part. We need to work together to support the Young Turks with mentorship and funding.

I really enjoy working with young visionaries because their minds are so expansive and without fear of failure they are constantly challenging the norms. However, many times the Young Turk's visions are so large, the details of what is necessary to actually bring it to fruition are not considered. They get snagged by the day-to-day aspects of building, growing, and sustaining a successful company.

What do I want you to do about it?

What I want you to do is the same thing I am doing, find Young Turks in your market and support them both from your years of experience and investment. If you are above the age of 50, your best way of retiring the way you envisioned is to have at least six revenue streams. Let the Young Turks provide the vision and the energy and you supply structure and capital.

I have partnerships where I have provided capital for equity in their companies and I'm there to make sure their stumbles aren't fatal. It's not my job to tell them how to run their company, but to allow them to work out issues through planning, research and analysis.

When life throws a curve ball, I ask them to walk me through what went wrong, if they cannot, we take the time to write out a course correction strategy with KPIs (Key Performance Indicators), a timeline and periodic check-ins to see how the strategy is progressing. Those that work are put into standard operating procedures and the others are reworked for other scenarios or dropped all together.


Once they have worked through a couple of problems and built the resulting adjustments, they begin to understand the value of planning, processes and systems and our check-ins are less frequent. Since I helped them realize the solution themselves, there is never a reluctance to come to me when there is an issue. We just go to the whiteboard and work it out.

Finally, we need more nontraditional forms of raising capital, whether it's family funds, opportunity zone funding or groups of individuals who have discretionary funds to lend. Access to capital will fuel the growing number of Young Turks who want to make money solving social issues. Whether its building tiny houses to offer a solution to homelessness or building state-of-the-art learning centers in underrepresented neighborhoods, these Young Turks are poised to have generational impact on our nation if they are given the proper opportunities and support.



DON'T LET YOUR PAST DICTATE YOUR FUTURE!

The economy may be thriving and the employment rate may be low in Marion County according to some reports, but if you have an arrest record or are a convicted felon, your chances of getting a good paying job, a better job or employment at all can be bleak.

Community Legal Services may be able to help. On Friday, February 21, they are hosting a Sealing and Expungement Clinic, from 11 a.m. to 2 p.m. at the Marion County Courthouse (Jury Assembly Room), 110 N.W. 1st Ave.

If your charges were dropped or adjudication was withheld, Lena Hopkins, Senior Manager of Pro Bono Services, Community Legal Services, encourages you to attend the clinic to meet with an attorney who will determine if you are eligible to have your charge sealed or expunged. If you qualify, the attorney will help you fill out the application.

"Removing certain offenses from one's criminal record can minimize or even remove some of the barriers that disproportionately impact underserved and minority communities such as access to employment or safe housing due to the background checks that are often required," Hopkins said.

Once a criminal charge is sealed or expunged, you can deny or withhold knowledge of a prior arrest from *most* prospective employers.

What can a felon do to improve their job prospects:

Highlight skills & experience:

Focus on relevant skills and work experience that are directly applicable to the job, emphasizing transferable abilities.

Be upfront about criminal history:

When asked about your criminal record, be honest and transparent, explaining the circumstances and any steps taken to rehabilitate yourself.

Seek support from organizations:

Many non-profit organizations provide job training and placement services specifically for individuals with criminal backgrounds.

Consider entrepreneurship:

Starting a business can be an option for felons who face significant employment challenges.



To participate in the clinic, your criminal case must have occurred in Marion County, and if you qualify for sealing and expungement, you will be responsible for a \$75 application fee.

"Our criminal justice system is built on the principle that a person is innocent until proven guilty. Yet, even when there isn't enough evidence, and the charges are dropped, the repercussions of the charge alone, can impact the rest of your life," said Silvia Lopez Smith, Community Legal Services, Pro Bono Development Attorney. "A criminal charge, will keep you from a better job, housing and higher education. If your charge is sealed or expunged, you literally have a second chance at life.

Pre-registration is RECOMMENDED.

MONEY SMART TIPS

DON'T BE RESPONSIBLE FOR DEBT THAT'S NOT YOURS!

This month starts with some good news for those of you who have medical or hospital debt. On March 17, 2025, a new Consumer Financial Protection Bureau rule means consumers' hospital and doctor bills can no longer weigh down your credit scores. According to U.S. News and World Report this will impact around 15 million Americans and bring their credit scores up by about 20 points. If you have recently applied for credit, a new apartment or any loan and been turned down due to a low credit score and think a 20 point boost would make you eligible, it might be time to try again if your score was low partially due to medical debt.

I write a lot about shopping with coupons and lately Digital Coupons. Last week I bought \$82.81 worth of items at a grocery store and only paid \$55.87 for them. The store receipt stated I saved 34% and that came with very little effort on my part. Clip the Digital Coupons on your store's website, look for Buy One Get One (BOGO) free items and other sales on items you normally use. When I see a great deal, I check the Best If Used By date then stock up on those items. If I can eat a bag of chips for \$2 it seems to taste even better than if I had paid \$4 for it.



If you or your spouse are in bad health check to see if you are joint owners of your credit cards. If you have a joint account with your spouse and you pass away your spouse is responsible for the debt. If you are an authorized user on a card but not an account owner in Florida you are not

responsible for this debt as Florida is not a Community Property state. If this is the case with you or your spouse, I would suggest calling the credit card company and changing from being a joint owner to becoming an authorized user. If you have a balance you might have to pay this off before you can make the change. Some financial experts even advise you not to be an authorized user so the credit card companies aren't tempted to come after you. Speaking of credit cards, I have warned you about high interest rates on store credit cards. Lately I have noticed that even regular credit card interest rates are going sky high. Capital One just wrote me that the rate on their Quicksilver card is going to 30.74%. Be aware of what your cards are charging you and close those with such high, unreasonable costs.

Valentine's Day is coming and without trying to sound unromantic I suggest you ask the special person in your life if you can celebrate on the weekend before or after Friday, February 14, the official Valentine's Day. Many restaurants raise their prices on this day and the wait can be so long it ruins the occasion. Many are so crowded and with a lot of illness going around it makes good health sense not to be part of that crowd. If you are in debt or on a tight budget perhaps taking care of a chore that has been on the Honey Do list for a long time, cooking a special meal at home or just a super good washing of your significant others car might be an appreciated gift without using your credit card or going further into debt. Be creative, what can you do, make or write (a love letter perhaps) that would mean just as much to your partner?

Federal Income Tax time is here and you can spend a lot of money getting your taxes prepared. If you earn a low to moderate income I suggest going online or calling the United Way of Marion County to sign up for their free VITA tax assistance program. You can request a specific date, time and location to meet with their representative. United Way has been offering this service for years and use only trained volunteers to help you prepare and file your income tax return. The closest location to West Ocala is the Marion County Literacy Council at 120 S.W. 5th Street.


