### **EDITOR'S DESK**



Summer is here, and this heat is nothing to play with! It seems like it gets hotter every year and lately it's been HOT!

As you're making plans to spend time with family and friends for the Fourth of July, at a Family Reunion or other outside gatherings or activities, please take precautions to keep everyone safe.

Check out the tips below to ensure you stay safe during this Summer and holiday weekend AND be prepared to deal with this hot weather.

### Tips to stay safe this Fourth of July

- Be careful if you're going to be near water. Keep your eyes on your kids at all times!
- Protect yourself from the sun. If you're going to be spending time outdoors, make sure you
  apply sunscreen at least 15 minutes before going out and reapply every two hours, especially
  after swimming.
- Use fireworks with caution. Only adults should handle fireworks. Make sure you check to see what fireworks are legal where you live.
- If you're barbecuing, never leave a lit grill unattended. Grill outdoors only and do not overload the grill to avoid potential flare ups.

#### How to Stay Safe in Severe Heat:

Be sure to take precautions to protect yourself and others from heat-related illnesses.

### 1. Stay Hydrated:

- Drink plenty of fluids, especially water, even if you don't feel thirsty.
- Encourage family and friends to drink lots of fluids too.
- If you sweat a lot, consider drinking a sports drink to replace lost salt and minerals.
- Avoid alcohol and sugary drinks because they can dehydrate you.

#### 2. Keep Cool:

- Spend as much time as possible in air-conditioned places. If you don't have AC, go to a library
  or a mall to stay cool.
- Take cool showers or baths.
- Wear lightweight, loose-fitting and light-colored clothing.
- Keep windows and curtains closed to keep your home cooler and try not to use heat-generating appliances like stoves and ovens.

### 3. Limit Outdoor Activities:

- Avoid activities that are strenuous during the hottest part of the day.
- Schedule activities for the cooler parts of the day, like early morning or late evening if you must go outside.
- Wear a hat or look for shade to protect yourself from the sun.

### 4. Be Aware of Heat-Related Illnesses:

- Know the signs and symptoms of heat cramps, heat exhaustion and heatstroke.
- If you suspect heatstroke, call 911 and get the person to a cooler place.
- **5. Check on Others:** Check on family members, older adults and neighbors who may be more vulnerable to heat-related illnesses.

Tania N. Sutherland believes that during these times everyone can use a little emotional boost. For more than 30 years, Sutherland has been independently recording and publishing music as well as working in the field of education. She uses Arts & Learn Exhibit, LLC., to boost self- esteem through the arts - specifically songwriting and broadcasting. Sutherland's consulting business operates remotely, in public settings or in agreed upon spaces, assists with portfolio development and homework help in specific subjects for students and sells advertisement slots on their Caribbean platform, Island Worldwide, a 24 hour broadcasting platform that connects broadcasters from all over the world including The United Kingdom, Canada and several states in the United States. "This unique small business also connects interested parties for professional mixing and mastering services as well," she said.

Sutherland said many Black Women Educators (BWE) in leadership have endured challenges of job sustainability, lack of job support and have been victims of systemic racism, but they are competent, educated, trained and serve populations that look like them but are lacking in education, yet, a very small proportion of BWE have achieved longevity in the field as evidenced in research in the United States.

While attending Howard University, Sutherland majored in Radio/Television/Film with a minor in Education. After graduating, she worked for several production companies including Showtime Networks, WNET, VP Records, NY Caribbean 93.5 FM and Westwood One Radio for several years. She said Howard University instilled entrepreneurship in its cultural and educational thread and as an alumnus, entrepreneurship was instilled in her. With influences, educational and life experiences and teachings from Howard University, recognized as the top historically black college and university (HBCU) in the nation, she birthed Arts and Learn Exhibit, LLC in 2023.

"Arts and Learn Exhibit believes that there is genius in everyone and aims to boost self-esteem through identity and social and emotional wellness through music, mentorship, broadcasting, tutoring and more making communities healthy with a sense of accomplishment, identity, value, victory and belonging," Sutherland said. "We showcase your work!"

Masterclasses are taught by an artist and educator who has a passion for giving back to the community. They serve adults and K-12 students and participants interested in broadcasting learn firsthand techniques of on-air nuances, script writing and programming.

### STAYING ON TRACK FOR THE SUMMER: WHAT KIDS CAN DO!

Are you halfway through the summer and wondering if your child is on track for a successful school year? In last month's issue, I wrote about teachers' expectations. This month, I would like to share some activities that your child can do now to prepare for next school year.

After speaking with a number of K-12 teachers, one thing is for sure, they want students to rest and enjoy their summer! It is understood that both teachers and students have had a long and tiresome school year. Everyone needs a break. However, just like teachers prepare over the summer for the next school year, students should too.

Some academic activities for elementary school students include reading and mathematics flashcards. I asked teachers if there were any computer programs that could help students, and they gave me the following list:

Cool Math 4 Kids, Epic! (Free for Educators); Khan Academy Kids; IXL; Brainzy and Educational videos on YouTube and PBS Kids

One elementary school teacher told me that she not only wants students to learn academic skills, but also life and independence skills. You can teach your child how to cook, do laundry, mow the lawn, and clean up after themselves. One second-grade teacher suggested her students complete summer camp.

After talking to secondary school teachers, it is apparent that they also had a long year and want your child to rest. However, there are things that middle school students can do during their down time to get them prepared for the next school year like going to the public library and reading all kinds of books. There are also educational videos on YouTube and other educational sites that are fun and engaging to watch.

For all students, it is important to note that when reading, one should sample multiple genres. One third-grade teacher told me that she wants her students to read at least one autobiography, a classic fictional novel, and some poetry. She encourages them to write in their journals and think of goals for the next school year. Finally, she wants them to practice multiplication fluency by timing themselves.

As a teacher certified to teach K-12 grades, I believe that all students should practice some type of mathematics flashcards over the summer. Elementary students can practice with number recognition, addition and subtraction, and multiplication and division flash cards. Secondary school students can practice the formulas and theorems that they learned in the previous year.

In conclusion, summer should be fun, but as rational beings, we are always learning. So, summer should be educational too! I suggest you support your child by helping them continue to learn throughout the summer. Teach your child life skills that will eventually make them independent adults starting in their primary grades. Have them read all types of genres of literature. Help them practice their math skills too, but most importantly, rest!

### **KDC AND THE SUNSHINE SLIDERS**

Katrina Colston Thomas' love for dancing started with Oralee Jackson when she was six years old and it's still a passion.

"I've loved dance ever since and have praised dance throughout my life," she said. Dance has always been a significant part of my life and spiritual practice."

In 2015, driven by her love for dancing and a personal story of passion, KDC and the Sunshine Sliders were started after Grace Huffman, who oversees the Barbara Washington Senior Center, asked her mother Annie Mae Colston if she could teach line dancing to some of the seniors.

Thomas said the name was inspired by KC and the Sunshine Band, an American disco and funk band that was founded in Hialeah, Florida in 1973. Since her mom liked the band so she suggested KDC and the Sunshine Sliders. The K represents Katrina, the D represents her sister Daphne and the C is for Colston and their love for dance and positivity.

KDC started with about three members and has grown to nearly 60 people. About 30 people attend the Beginners class and the other half attend the Intermediate and Advanced classes. They perform about two to three times a month. Currently performances are free, but beginning in 2026, they plan to charge a set fee to perform.

Thomas recently saw the need to add a children's line dance class after Ms. Dowing, one of the ladies in KDC, suggested it. She agreed to start a class if Dowing led it. When Dowing moved away, Thomas' daughter Kristy Robinson and her sister Daphne Colston took over the class, which is called KDC Kids.



The youngest participant in the adult class is 13 years old and the youngest in the kids' class is 3 years old. Classes are unisex and anyone can participate in any class.

"It's been a blessing and the kids love performing," she said. "The program promotes development, learning and positive values beyond dance."

Thomas said KDC is her full-time focus, but she dedicates time to nursing homes and churches when she's not dancing. She said KDC supports various community initiatives such as organizing Christmas gift drives, hosting Mother's Day events, participating in the local Martin Luther King Jr., activities and the Ocala Christmas parade. KDC also adopted the Avante Nursing Home and organized prom dress drives and hosts two annual yard sales at New Zion Missionary Baptist Church in partnership with the Ocala

Police Department.

KDC also partners with the City of Ocala Recreation and Parks, Smooth Flavor, which is based out of Gainesville and others. Currently, they don't receive any outside funding but rely on annual fundraisers, i.e., a popcorn sale and scholarship event, but they welcome community support although they are currently not a 501(c)(3) organization. The goal, she said, is for KDC to become one in the future so they will be eligible to apply for grants, receive tax-exempt status and contributions from donors would be tax-deductible.

"We aim to avoid burdening the community, but would appreciate donations of blankets, toiletries and stuffed animals for nursing home residents," Thomas said. "Our kids' line dance group needs uniforms, and we also plan to buy gifts for our Mother's Day event."

Long-term, Thomas wants to expand KDC into a community-based program that promotes positivity and youth development, fosters collaborations and creates sustainable, innovative projects that serve the community.

"Right now, we focus on showing up with love, peace, happiness and prayer for prosperity," she said.

Thomas said she never expected

the group to be as popular as it is. She said they pray during class, host monthly scripture readings and hold quarterly birthday celebrations for fellowship.

"I feel blessed, it has grown beyond my expectations," she said. "Initially, it was just me, a few women and my mother dancing for fun. Now we have a vibrant youth presence and God's favor has been evident."

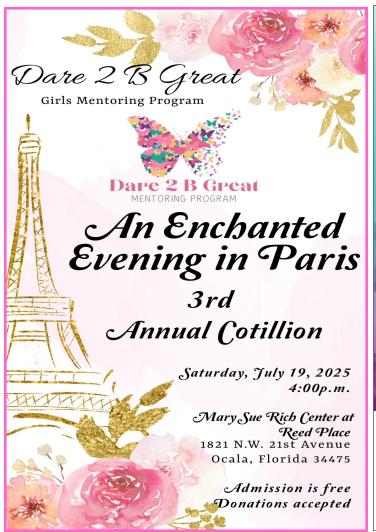

### CALL TO ARTISTS: EIGHTH BIENNIAL OCALA OUTDOOR SCULPTURE COMPETITION

The City of Ocala Cultural Arts Division invites sculptors from across the United States to submit entries for the Eighth Biennial Ocala Outdoor Sculpture Competition. This juried, two-year exhibition offers artists a unique opportunity to showcase their work in one of Ocala's most visited public spaces, Tuscawilla Park and the adjacent Art Park.

Up to ten sculptures will be selected for display from January 2026 through January 2028. Selected artists will each receive a \$4,000 honorarium to support transportation and installation of their work. The City of Ocala will provide concrete pads, limited installation assistance and insurance coverage for installed pieces up to \$15,000 or the artwork's stated value, whichever is less.

The exhibition will be celebrated at the Tuscawilla Sculpture Stroll on Saturday, February 21, 2026. Juried awards will include Best in Show (\$2,000), Second Place (\$1,000), and Honorable Mention (\$500). Event attendees will also vote for the \$1,000 People's Choice Award.

Eligible applicants must be U.S. residents (excluding Alaska and Hawaii), age 18 or older. Submitted sculptures must be completed after 2020, structurally sound, maintenance-free, and able to endure Florida's subtropical climate for two years. Delivery and retrieval must be made in person by the artist or their representative.

Each artist may submit up to three sculptures for consideration. Application materials must include at least three high-quality images per work, an artist resume, a statement specific to the submitted work, and artwork details including title, medium, dimensions, weight and value. ### MONEY SMART TIPS

### DO YOUR HOMEWORK SO YOU DON'T GET SCAMMED!

I use Norton 360 as my virus protection for my laptop computer. I like the product but the company's billing policy upsets me every year. Once again they billed me for the next year five weeks in advance and with no advance notice. When they do this, they charge you \$139.99, much more than you can buy this protection from other retailers. As the cliché states, to add insult to injury, nowhere on their website can you find a phone number to contact customer service. After much research I did get a phone number (866) 425-0365 and after listening to a couple of their counter offers, which I turned down, I threatened to cancel and switch to McAfee. Then they offered me the price of \$69.99 which I accepted. The two lessons here are by asking and insisting you can often get a better price and if you have Norton, be warned that this is their standard practice and you need to be very careful with your renewals. If you sign up for automatic renewals to get a better price, make sure you turn off automatic renewals in settings at least two months prior to the expiration date.

Someone I know well almost lost her life savings to a scam in the middle of June. She received an email from Microsoft telling her that her identity had been stolen and all her financial information was on the Dark Web. There was a phone number to call and she carefully verified that the number listed belonged to Microsoft so she thought it was legitimate. When she called she was told she was being transferred to a federal agent and over the next two days they convinced her to withdraw all her money from the bank and because they didn't have a federal agent in this area available to pick up her money for the "required 48" hours" she was told to put her cash in books with the pages hallowed out and to mail them to an address they gave her. They told her she couldn't report this or tell anyone or all her personal information including false criminal charges would be made public. She finally went to the Sheriff's Office and they told her immediately that it was a scam. They tracked it back to its source and she was able to deposit her money back into her bank account. With Artificial Intelligence and modern technology criminals can make a phone number look like it came from or is going to a different number than the one you see. Be very careful when responding to any request for your money or personal information. To verify, go to the company's or agency's official SECURE website (look for a https URL, not http) and contact them to ask if the information you received is legitimate.

I learn so much from reading Clark Howard's articles and listening to his podcasts. He recently shared another way criminals can get your money. His advice is never use public charging stations for your cell phones. These are often found at shopping centers, some fast-food restaurants, airports and other public buildings. The bad guys have learned how to plug into a public charging port and load malware into that port. When you plug into that port to charge your phone they can then steal all the information from your device, including your passwords stored on your phone. This is called Juice-Jacking, Clark suggests you carry your own charger and USB cables when traveling, bring an external battery for your phone or buy an inexpensive "charging only cable" which will not allow data to pass in either direction to protect yourself.

Last tip of the month. I just had a prescription filled, a onetime need, not a regular script. With my insurance it was \$30.67 so I asked the pharmacist to check the price using GoodRx and my new BuzzRx card that I have with Wellcare. My cost ended up being \$16.84. Even if you have insurance don't forget to check the price with GoodRx or any other discount card you may have.

### GENERATIONAL FARMING: A LIVING LEGACY

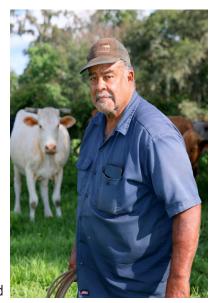

As a little boy growing up in a farming community near Belleview Santos, Homer Gary, II said he knew since he was old enough to understand that he would eventually run the family farm. Today, Gary, a farmer and rancher, owns Homer Gary Family Farm, LLC.

Gary's grandfather, William P. Gary, started the farm after moving his family to Florida right before the Great Depression. William and Homer's great-uncle, John Gary, were among the early settlers of Marion County settling on 160 acres in South Ocala. After his grandfather passed away, Gary's father, Homer Gary, Sr., started managing the farm and when he died, Gary stepped in to continue the family legacy.

The Gary Family Farm has a longstanding tradition of hard work and commitment to education despite the limited resources and many challenges historically faced by Black Farmers. Homer Gary Sr., supported by his family, made many sacrifices to ensure his children had the opportunity to pursue a college education. Homer Gary II and his wife, Jacquelyn Boyd Gary, continued that legacy by prioritizing education for their children.

"My Father, Homer Gary, Sr., was my mentor. He taught me things you don't learn in a book. Hands-on experience is the best teacher," Gary said. "He told me to always trust God, pray and thank God for every blessing. The farm must be a top priority, and I must be dedicated and work hard."

Gary still upholds and preserves the family's farming traditions, practices and values, which have been passed down through generations centered around raising cattle and baling hay. They no longer grow watermelons, tomatoes, peas, squash and cantaloupe like they did in the early years.

A typical day on the farm varies depending on the time of year, the weather and unexpected events. This time of year, Gary starts his day at sunrise checking on the animals at the main location and inspecting the fencing. Then, he goes into town to hire laborers to help with feeding and other tasks. He picks up supplies while in town and tries to visit each location to feed the animals, check the water, assess their health and inspect the fencing.

### Other tasks include:

- · Deworming animals and placing medicine on animals for parasites.
- · Weaning calves for replacement and marketing.
- · Checking on pregnant cows who might need help delivering.
- · Spraying fields for weed control.
- · Cutting and baling hay

Gary's most significant achievements so far have been the implementation of sustainable farming practices, which allowed the family to upgrade operations and expand to multiple sites totaling approximately 1,000 acres across the Shady Grove, Sparr, Martin and Fairfield areas. Despite the growth, the heart of the family farm remains in South Marion County where the fifth generation of Gary farmers are preparing to carry on the legacy.

Gary said farming is his livelihood, and he has no regrets about his life as a farmer. He enjoys what he does; however, as he gets older, he is unable to perform many of the necessary tasks to keep the farms running, so his sons, grandson, nephews and other workers are hired to help maintain the farms.

"If you're interested in farming, you need to know that farming is hard work," he said. "You must be dedicated, understand how the market fluctuates, expect disappointments and seek help from experienced farmers."



Gary welcomes visitors to the farm by appointment and teaches farming skills to students at Career Fairs and Youth Fairs. He also shares his knowledge with other farmers and supports the agricultural industry by making financial contributions to several farming organizations and initiatives.

In addition to community engagement, Gary produces beef for consumers and continues to bale hay as part of the farm's operations.

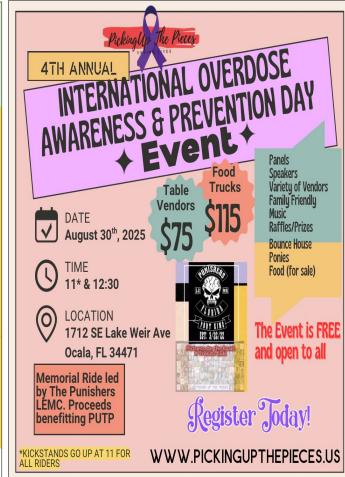
